Rubber Ducky Reading Club

The Rubber Ducky Reading Club is for children from birth to age 5. This program is a fun revamp of the children's literacy effort called 1000 Books Before Kindergarten, which was created to encourage parents of children up to 5 years old to read aloud age-appropriate books to ensure that young students are at or above reading level by the time they enter kindergarten.

To begin this free program, stop by the Children's Room and pick up a reading log. If you need reading suggestions, our helpful staff members can help you find some books to read that your child will enjoy. Read a book (any book) to your newborn, infant, and/or toddler. For every 10 books recorded on the reading log, the child will receive a small reward – possibly in the shape of a rubber ducky! For every 100 books read, the child will be given their very own book to take home and keep.

Family Reading Night

Youth Services once again will team up with the Vermilion Valley Reading Council, an affiliate of Illinois Reading Council, to present “**Family Reading Night**”, which will be held in November (exact date to be determined) from 3:00 to 4:30 p.m. in the Children’s Room.

Families will travel to five stations set up in the room where they will listen to stories and create their own storybook. They will receive reading mementos, bags and books to take home with them.

3D Printer Classes for Teens and Tweens

For several months now, Youth Services has offered classes that allow teens (ages 12–18) and tweens (ages 8–11) to design creations in 3D printer software to be printed on the 3D printer. The teen class is usually scheduled on the 1st Thursday of each month and the tween class is offered on the 3rd Thursday of each month.

Due to the hands–on nature of the classes, they are kept small and fill up fast, so registration is required: teens may register in the Teen Space, tweens may register in the Children’s Room; either may register by calling 477–5220 and asking for the appropriate service desk.

QUICK LIST OF COMMON WAYS TO GIVE

The IRA Qualified Charitable Contribution Rule as of December 18, 2015

One key benefit of the direct charitable contribution from your IRA is that the distribution counts toward your annual Required Minimum Distribution (RMD). IRA charitable contributions have numerous federal income tax benefits compared to other charitable gifts. Another advantageous gifting option to consider are gifts of appreciated investments which would otherwise qualify as long-term capital gains. Both gifting options may significantly reduce income tax liability. Please consult your tax advisor for more information on the benefits and limitations of charitable gifting.

Bequests

Bequests are the cornerstone of most estate plans and among the easiest ways for donors to arrange a gift. Donors set up a bequest when they work with their attorneys or legal advisors to draft their wills. Please remember the Danville Library Foundation in your plans and we can answer your questions about how a potential bequest might be used.

Life Insurance

Is a wonderful, yet overlooked, tool for making a gift. A gift can be set up by the donor, selecting your charity as a beneficiary of all or a portion of the policy's proceeds.

Retirement Plans

Individual Retirement Accounts and pension plans through your employer or your own can set your charity as a beneficiary of the remaining balance. These gifts are arranged by donors contacting the administrator of your plan.

Financial Service Products

Donors can select your charity as the beneficiary of these accounts through a payable-on-death provision.

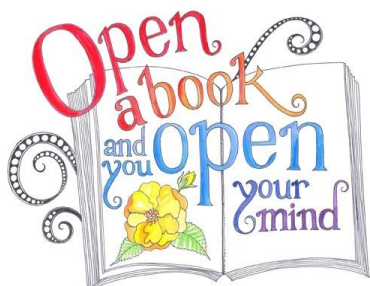

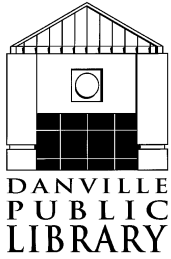
